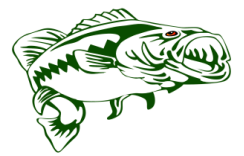

- Fish will be judged on weight. In case of a tie, the earliest fish registered will be judged the winner.
- Only one prize per contestant.
- Howard Lake Good Neighbor Days Committee reserves the right to reduce prize monies only if insufficient entries are received to cover prize money and expenses.
- **If severe weather** is present contest will take place later in the day. No refunds will be allowed.

- All walleyes entered must be 14 inches or longer to qualify.
